EQUIPMENT:

Equipment and systems covered by this Certificate are as follows:

The Explosion-proof Emergency Box model BXP02□-L□-L□, is constructed in explosion protection type flameproof enclosure "db" for Gas environments, and in explosion protection type protection by enclosure "tb" for Dust environments. The emergency power and battery pack are mounted inside the Ex db chamber, together with connection terminals. The metal enclosure parts are made of aluminum alloy 101A with a minimum thickness of 3.0mm. The enclosure is fitted with three threaded (M20×1.5, M25×1.5, NPT1/2" or NPT3/4") openings for cable glands and stopping plugs.

For nomenclature and other information, see the Annex to this certificate.

SPECIFIC CONDITIONS OF USE: YES as shown below:

The ambient temperature range is limited to -25 °C ... +55 °C.

The width of flameproof joint is more than the minimum values specified in IEC 60079-1 standard. If needed, repair of the flameproof joints must only be made in compliance with the structural specifications provided by the manufacturer. Repairs must not be made on the basis of values specified in table 4 and table 5 of IEC 60079-1:2014.

If the product is delivered with integral cable glands, no other cable glands can be applied. In this case, only the cable gland parts supplied by the manufacturer shall be used.

If the product is delivered with stopping plugs, the user must apply IECEx certified cable glands, rated minimum IP66, suitable for the conditions of use and correctly installed.
